Throughout this process, we continue to engage openly with all competent institutions, guided by a spirit of transparency, mutual respect, and adherence to the law. For example, under the leadership of our Chairman of the Supervisory Board, we plan to form an external team to conduct a deep self- investigation for the entire period offering close cooperation and assistance to Albanian authorities.

We hold high hope in the integrity and fairness of the Albanian judicial system and remain hopeful that this matter will be addressed with the impartiality and diligence it deserves. We also express our sincere wish that the current security measures affecting members of our team will be reassessed in a manner that safeguards the continuity of our operations and reinforces confidence in the pursuit of justice.
